- 1984-2010- MSRC PR Section members (25+) *actively* collaborating for coding and reimbursement for programs. Document published in mid 1980s.
- 1985- created Lung Awareness Day in conjunction with ALAM
- 1997-2002-National Emphysema Treatment Trial (NETT) Satellite Programs.
- ? Pulmonary Rehab Section begins having an anual one day seminar
- 2001- Diagnostic Section added
- o 2002- Full MSRC Fall seminar
- 2002- CPT Codes for Respiratory Services (G0237, G0238, and G0239)
- 2009 Collective communication (Letters) with CMS/ AARC/AACVPR lobbyist for open comment period for COPD coding.
- 2010- CPT Code for Pulmonary Rehabilitation (COPD) G0424.
- 60+ PR Programs in MI

#### AACVPR CERTIFICATION

- Certification demonstrates that your program is aligned with current guidelines as approved by the leading governing body that dictates standard of care. (AACVPR)
- Hospital administrators embrace program certification as a vehicle to demonstrate excellence for JCAHO.
- Certification offers peace of mind to knowledgeable consumers. Certification can also help patients decide between your program and an uncertified program in your area.
- 3 year Certification at the cost of \$780 for the first round and \$660 thereafter.
- Need to research how many programs in MI are certified.

#### What is the Registry program all about?

- Established program-based and national outcomes for PR, allowing programs to:
  - Create and manage patient profiles
  - Enter and view outcomes data in real time
  - Track and quantify progress in meeting performance goals
  - Produce individual and grouped outcomes reports

# Why should you consider participating in the registry?

- Compare outcomes/processes to evidence-based goals and national benchmarks
- Implement quality improvement projects on real data
- Enhance documentation and communication with hospital administrators, referring physicians, etc.
- Promote the role and effectiveness of PR in the management of chronic lung disease
- Increase physician support
- Improve 3<sup>rd</sup> party payer coverage and reimbursement rates
