Sputum Bowl 2026 Reminders

- 1. Participants will conduct themselves in a professional manner and display good sportsmanship.
- 2. Alcohol consumption by team members during any game is prohibited while competing.
- 3. Video or audio recording of any game is prohibited.

 The team will be disqualified if a team member or supporter is found to be video or audio recording any match.
- 4. The number of questions for student submission is 20. A question from each category (airway management pharmacology) is required. There are 19 categories, so each team will need to add 1 additional question for a total of 20.
- 5. The number of teams is limited to the first 16 registered teams. A waiting list will be maintained in case a previously registered team drops out before the competition.
- 6. Each team is required to have a team sign that includes the Team Name and the College they are representing. The recommendation is to utilize a foam or poster board that is 2 feet by 3 feet. This helps the moderator and scorekeeper identify each team during the competition. See Appendix G
- 7. New Category Grouping: Emergency Care / Critical Care. Critical Care has been added to Emergency Care. Cardiopulmonary Rehabilitation was previously Pulmonary Rehabilitation. Home / Long-Term Care is now grouped together.
- 8. On Line Bracket from 2025 Competition. See Appendix E.

MSRC SPUTUM BOWL

RULES OF COMPETITION

The primary objective of the Sputum Bowl is to stimulate interest in the current knowledge and practice of respiratory care. The competition shall be held in a spirit of professionalism and good sportsmanship. Teams should conduct themselves with this spirit in mind. There are no losers in this contest. All should have a better understanding of respiratory care and themselves from this experience.

1. Submission of Teams

- A. An application must be received by the MSRC by Friday, March 13, 2026.
- B. The Sputum Bowl Committee must receive the required questions from each team by Friday, March 20th, 2026, at 5:00 pm. Please refer to Rule X and Appendices A
 D. If questions are not received on time, the team will be subject to disqualification, unless prior arrangements have been made.
- C. Membership to the AARC and conference registration must be received by March 27, 2026.

2. Team Composition

- D. A team shall typically consist of four (4) team members (three players and one alternate). A team is not required to have an alternate.
- E. Team members (herein considered the team) must be current members in good standing of the American Association for Respiratory Care (AARC). Team members who have just recently become AARC members but do not have an AARC number yet will still be able to submit an application for the competition. However, the Sputum Bowl Coordinator must receive new AARC membership numbers from the AARC office before the start of the competition, or the team will be subject to disqualification from the competition.
- F. All team members of the championship student team shall be ineligible to compete in their respective class for one year. The only exception to this rule is a first-year. student team winning. The team may return as a second-year student team the following year.
- G. Team members must be registered for a minimum of one day at the MSRC Annual Spring Conference.

3. Format for State Competition

- H. The State Competition will be held in conjunction with the MSRC Spring Conference.
- I. Preliminaries will normally be held on the first day of the conference.
- J. A random drawing will determine the initial pairings.
- K. When feasible, first-year students will be placed in a pool separate from secondyear students for the initial drawing. An attempt will be made to avoid pairing teams from the same school.
- L. The competition will continue throughout the day until only four (4) teams remain.
- M. Finals will be held on the second evening of the conference.

4. Sputum Bowl Coordinator and Committee

- N. The Sputum Bowl Coordinator oversees marketing, management, and evaluation of all phases of the event.
- O. The Sputum Bowl Coordinator shall review the team's eligibility before and during the competition to determine if any irregularities exist.
- P. The Sputum Bowl Coordinator and Committee shall be responsible for the physical setup of the contest site, ensuring the proper functioning of all equipment, addressing questions, and making all other necessary arrangements to ensure a smoothly run competition.
- Q. All matches will be recorded. The Sputum Bowl Coordinator's responsibility is to ensure this is undertaken. The recording will be made available to the judges upon request.

5. Moderator

- R. The moderator shall be someone familiar with the terminology and practice of the profession and shall be appointed by the Sputum Bowl Coordinator.
- S. The moderator shall have the option to accept or reject an answer without asking for the judge's ruling.
- T. During the game, the moderator is responsible for maintaining order in the match.
- U. Question selection is at the discretion of the moderator.
- V. The moderator shall review all questions before the competition to determine the limits of acceptable alternate responses to each question and determine sets of questions for use during each round of play.

6. Judges

- W. The judges shall be individuals who are qualified within their respective fields.
- X. When feasible, the judges shall not be directly related to teams involved in any specific contest.
- Y. The judges shall rule on the response to any question that the moderator desires and indicate whether they accept or reject a team's answer. All decisions shall be final and not subject to the protest process.
- Z. The judges will keep the official score for each game. Any irregularity in scoring between the official score and the scorekeeper's score should be rectified immediately by the judges notifying the moderator.

7. Score / Timekeeper

- AA. The Score/Time Keeper will be responsible for keeping the running score and time during each game.
- BB. The clock will start with 10 minutes. 20 minutes for the Championship game.
- CC. The timekeeper or moderator may stop the clock at any time during the match.
- DD. The timekeeper will stop the clock, so the bonus/penalty phase is a full 2 minutes.
- EE. The clock will be stopped until the Expert reaches the team or the microphone reaches the Posse. The clock will restart, and 10 seconds will be given for a response.
- FF. The Score/Timekeeper will signal the end of play when the clock reaches 0:00.

8. The Competition

GG. Preliminaries

- 1. The game will consist of two teams in the competition.
- 2. Each game will be ten (10) minutes in length. The team scoring the most points at the end of ten minutes is the winner of the match.
- 3. Team pairings will use a double-elimination format.
- 4. If a team is not on time for their game as scheduled, the team that is present will be seated. At the time the game is scheduled to start, a 60- second clock will start. If the missing team does not arrive prior to the clock expiring, the team that is present will be given a win with a score of 1-0. Under extenuating circumstances, the committee will discuss and vote on whether a team is permitted to play.

HH. Finals

- Four teams will advance to Finals night. There will be two semi-final matches.
 The winner of those matches will play in the championship match.
- 2. Each semifinal match will be 10 minutes in length.
- 3. The championship match will be 20 minutes in length.
- 4. The winner of the championship match will be awarded first place. The runner-up will be awarded second place.

9. General Rules

- II. The moderator shall signal the beginning of each match.
- JJ. The Score/Timekeeper shall time the length of play and announce the end of the match. The score/timekeeper shall maintain a running score, which is visible to all participants and the audience.
- KK. The moderator will ask the questions, indicate the team that responded first, and await the answer. Then, the moderator will judge the first answer given as to its correctness, and if correct, indicate it to the scorekeeper.
- LL. Each team, after buzzing in to answer a question, shall have ten (10) seconds to begin an answer. Failure to start answering within ten seconds will result in a missed question and allow the opposing team to answer. An attempt to stall by saying, "The answer is..."(or any other phrase that is not a part of the answer) will not be judged as the beginning of an answer. Team members have the liberty to confer during this time.
- MM. If Team A responds to a question before the moderator has read the complete question, then Team A will have to attempt to answer the unfinished question. All questions during the competition before the Bonus Phase shall be played under a Risk/Reward policy (see JJ.) Only the moderator can determine if a team is at risk.
- NN. There will be a Bonus Phase during the last two minutes of preliminary matches and the last four minutes of Finals matches. During the Bonus phase, if team A buzzes in and is correct, they will receive (+2) two points. If team A is incorrect, one point is deducted (-1). If team A is incorrect, team B will get a complete

- reading of the question. If team B is correct, they will receive one (+1) point; if incorrect, (0) points will be deducted.
- OO. If neither team responds to a question within ten seconds after the moderator has completed its reading, the question will be set aside, and questioning will continue. A team cannot have points taken away that result in a negative score.
- PP. Video or audio recordings of any competition is prohibited. If a team member or supporter is found to be video or audio recording of any match, that team will be disqualified.
- QQ. If, due to moderator error, a question must be thrown out after Team A has already missed it and before Team B has had a chance to answer the question, the next question will be read to Team B, who will have ten seconds to respond. Any points lost by Team A on the first question shall stand. Team B shall earn points on the following question based on a correct answer. The moderator shall have the freedom to select questions in any order and throw out questions at any time.
- RR. Risk/Reward All questions before the bonus phase during the competition shall be played under a Risk/Reward policy, whereby if a team responds by buzzing in before the completion of the question being read, the moderator will identify the team as "at risk." If the team answers correctly, the team will be rewarded with one point (+1). Conversely, if the team does not answer correctly, one point is deducted (-1), and the moderator will re-read the complete question for the opposing team. The opposing team earns one point with a correct answer. An incorrect answer will result in 0 points. Only the moderator can determine if a team is at risk.
- SS. Ask the Expert This is for the Preliminary matches only. Each team can choose an expert as a lifeline used once during a match. The team can use this lifeline if they want assistance with a question. The expert can consult with the team, and either the expert or any team member must answer the question within 10 seconds after the expert reaches the team. The expert must be identified before the match to the moderator and will be seated in proximity to the teams. The Sputum Bowl Committee Chair has the right to disqualify any expert who is either providing the teams with clues or is otherwise not participating within the spirit of the game. The expert will face the audience with their back to the team. The Expert can't be used in the last 2 minutes of the game.

can only be used once during the match. Each team will have a designated table at the beginning of the match.

This table would have their team's Posse, which may include up to 6 people. The team can use this lifeline if they want assistance with a question. The Posse cannot consult with the team to answer the question. The Posse must answer the

Call the Posse – This is for the semi-final and championship matches only and

- question within 10 seconds after the microphone has reached the table. The Posse can't be used in the last 2 minutes of the Semi-final game or last 4 minutes of the Championship game. Risk / Reward remains in effect during this time.
- UU. A playoff shall resolve tie games at the end of regulation play with no time limit. The first team to score three (3) points shall be declared the winner. **Risk / Reward** remains in effect during this time.
- VV. If a question is asked and a team commits to answer as the time clock runs out (00.00), they will be allowed to complete their answer. If not answered correctly, the opposing team will have the opportunity to answer the question in accordance with the rules above.
- WW. Alcohol consumption by team members while on stage during any match is prohibited.
- XX. The winning team at the state competition must be able to field a team in accordance with the AARC rules for all eligible matches at the National level. In addition, the winning student team must be enrolled in a Respiratory Therapy program during the state competition. If the team cannot do so, the 2nd place team will be offered the opportunity to compete at the Nationals.

9. Questions / Requirements for Student Teams

- YY. Il student teams must submit 20 questions. The questions must include at least one question from each category and have an appropriate reference. Refer to Appendix B.
- ZZ. The Sputum Bowl Committee (SBC) believes the game will benefit from more clinically relevant questions.
 - AAA. The questions shall represent the level of didactic and clinical proficiency a therapist is expected to possess.

 BBB. All questions shall be referenced to the list in Appendix A.

TT.

CCC.All questions shall pertain to one of the categories in Appendix B.

DDD.Questions shall be submitted following the required format:

- 1.Questions should be entered into the Excel spreadsheet (Appendix G) and sent via e-mail to the MSRC Keeli Baker (kbaker@mhsa.com).
- 2.Questions will include the category, question, answer, reference and page number, and team name (See example in Appendix C).

EEE. The following types of questions are **UNACCEPTABLE**:

- 1.True/False and Yes/No questions
- 2. Multiple choice questions
- 3. Fill-in-the-blank questions

FFF. All questions shall be reviewed before the competition.

GGG. Those questions not written in accordance with the above rules will be returned to the submitting team for revision. Teams that have to revise their questions will be given a one-week extension to the deadline mentioned above. HHH. Visual questions shall follow the format outlined in Appendix C.

10. Challenging the Competition

III. Teams are asked to wait at the contest site for two minutes after the completion of a game to learn of any protests related to the contest.

JJJ. All competitions will be recorded to provide a record of the proceedings.

KKK. The team captain must submit a written challenge (Appendix F) to any portion of the competition within five minutes after the completion of the game in which the protest is claimed.

LLL. All Sputum Bowl Competition references are onsite for the Review Committee only (Review Committee consists of):

- 1. Sputum Bowl Coordinator
- 2. Moderator
- 3. Timekeeper / Scorekeeper
- 4. Judges

MMM. The review shall consist of the following:

- 5. Protesting team captain stating discrepancy and any supporting material (limited to two minutes).
- 6. Any rebuttal from the opposing team captain (limited to two minutes).
- 7. The committee reviews all material pertinent to the proceedings.

8. The final decision voted upon and decided by the majority of the Review Committee shall be completed before the next match. A member of the Review Committee shall announce the final decision and rationale.

NNN. A special limiting provision to a challenge is that a team cannot win a game solely based on a protest decision. In other words, the only outcome of a decision in favor of the protest is the possibility of a tie game and, therefore, a chance to win in a sudden death playoff. If the losing team is behind by only one or two points, a favorable decision may bring the team's score up to that of the winning team (i.e., a tie). Challenges are moot if the teams are tied anyway at the end of regulation play (since the best outcome is a tie score via a protest decision). This eliminates the possibility of a losing team defeating the winning team based solely on the decision of the Review Committee.

11. Electronics System

OOO. In the case of an electronic malfunction, the moderator will stop the match. The clock will be reset to the time when the malfunction was first noticed. The question in progress will be thrown out. The moderator shall signal the resumption of the game and begin with a new question. No points will be awarded on the question thrown out, nor may they be deducted if the team answering was at risk. Before restarting play, the moderator shall ensure all systems are operational and clear.

12. The Trophy

PPP. To safeguard the trophy, it will be kept by the MSRC Sputum Bowl Committee.

QQQ. Team plaques will go home with the winning team and runners-up.

APPENDIX C: Visual Question Format

A. Visual Question Criteria

- Subjects for visual questions should predominantly be items or scenes a typical respiratory care practitioner can reasonably be expected to recognize. The visual questions should require recognition or analysis of the visual image to compose a correct answer and not simply provide a visible background to a traditional oral question.
- 2. Each visual question shall consist of an image attached in digital format (jpeg preferred) and a numbered question on a PowerPoint slide. The information required for each question is listed below. The images submitted do not have to appear directly in the reference, but the content of the question and answer shall be referenced to the list in Appendix A.
- B. Suggested Visual Question Types
 - 1. Interesting scenes of any aspect of the practice of respiratory care.
 - 2. Realistic, staged illustrations of the practice of respiratory care.
 - 3. Items of equipment
 - 4. Anagrams

C. Unacceptable

- 1. Equations
- 2. Slides consisting only of words
- 3. Copyrighted photographs or cartoons
- D. Visual questions will be submitted electronically as a PowerPoint slide. The question should be included in the Notes section of the PowerPoint slide. Below is a sample picture and question.

Visual #1 – Category is Airway Management Q: The RRT pictured here is performing what emergency procedure for the benefit of a conscious choking victim?

a) These questions will require a team to perform a calculation to determine the correct answer. Each team will have a simple calculator, pencil, and paper.

Q: Listen carefully; a patient receiving mechanical ventilation has a set respiratory rate of 12 bpm and a set tidal volume of 500 mL's. The patient is currently apneic. Calculate the patient's minute volume.

3. Interpret This / Diagnostics

a) These questions will require interpreting patient-related data. This may include ABGs, PFTs, EKGs, Ventilator Graphics, etc.

A: Erroneous blood gas result

 - a) These questions would include a minimum of 3 clues going from general to specific. As more clues are given, the answer becomes more apparent.

Q: a) I am classified as an obstructive condition. b) I am less likely to occur now than in the past due to antibiotic therapy c) I often accompany cystic fibrosis d) I may be classified as varicose, saccular or fusiform. Who Am I?


